WHAT WE LEARNED SO FAR

- Streetscaping should be low maintenance and Compliment Existing Borough Streetscaping Standards.
- Driveway Alterations and Modifications, as well as Property Access During construction is required for new Sidewalk Installation.
- Assess Access and Driveway for properties along South Avenue to improve safety and Compliance with NJDOT Access Management Code. Pursue waivers from NJDOT where warranted.
- Right of Entry to adjoining properties will be required for sidewalk and driveway installation.
- New design should consider Future Borough Redevelopment and Other Known Proposed Site Development.

PROPOSED IMPROVEMENTS SUMMARY

Description of Proposed Improvements

- Replace Existing and Construct New Sidewalk and Driveway Aprons.
- Realign Old South Avenue and improve access onto South Avenue.
- Where required, restore pavement on adjoining properties fronting sidewalk, replace existing curb, install new traffic stripes and signage, new ADA compliant curb ramps and install new crosswalks across sideroad intersections. No new midblock crossings are proposed.
- Streetscaping including new textured sidewalk, ornamental street lights, decorative benches, trash receptacles, planters and street trees with grates.
- Construct bike parking area near Train Station including bike racks and repair station.
- Consult with NJ Transit and NJDOT on installation of new bus shelters at bus stops on South Avenue within Project Limits.






