STREET OPENING PERMITS

<u>APPLICATION FEE:</u>	Normal \$50	Non-reported opening: \$250
<u>PERMIT FEES:</u>		
Up to 20 SF:	\$125	Between 20 & 80 SF: \$250
Additional over 80 SF:	\$3 per SF	Each 30-day permit extension: \$25
<u>INSPECTION FEE:</u>	\$150	
<u>CASH BOND:</u>	Up to 43 SF: \$1000	Over 43 SF: \$24 per SF per opening
*Utility companies exempt		

Multiple openings are a minimum of \$800 each.

Newly paved roads (three years or less): up to \$10,000 as determined by Borough Engineer.

CURB PERMITS

<u>APPLICATION FEE:</u>	\$30
<u>PERMIT FEES:</u>	\$0.50 per linear foot; \$75 minimum
<u>INSPECTION FEE:</u>	\$150
<u>CASH BOND:</u>	\$15 per linear foot
